Education Report: Jack Leyden noted that the Amherst Seminar and Conference will be celebrating their 50th Anniversary this year and urged members to attend for both the educational classes and the dinner. ICC Testing will also take place at the college. Visit the ICC website for more information. Jack also said that State certified building code officials will be issued new identification badges in October. The badge will also have a computer chip embedded to track attendance at future education events by swiping the card. His office will send out more information to all when the badges are ready to be issued.

Scholarship Committee: Dave Murphy presented the recommendations of the Scholarship Committee. There were four options presented, one based on the amounts awarded last year, one based on a scaled back version of last year, one based on 50% of the profits to be awarded and the other 50% to be placed in the E & J fund, and the last a rounded up version of the 50/50 split. The proceeds from the Golf Tournament were \$12,233.61. Dave recommended a scaled back version of last year's awards. The awards range from \$750 for first year recipients, \$500 for second awards, and \$300 for third award. The total to be awarded for the fifteen (15) qualified applicants is \$8,950.00, with the balance of \$3,283.61 to be deposited into the Scholarship fund. A motion was made by Richard C., seconded by Ben N. to accept the recommendation of the Scholarship committee. **(All members approved).** Thanks to Scholarship Chairperson Dave Murphy and members Warren Ducharme, Bob Speaker, Stan Dickenson and Steve Gianlorenzo.
