## Day One, Monday, March 28, 2011

### **A) *The Politics of Codes Instructor Ron Piester***

This course helps Code Officials to sharpen their political skills, covering the following topics:

### **B) *Construction in the Flood Plain Instructor Nick Agnoli-FEMA***

This conference presentation will cover the basics of determining the flood zone associated with a commercial, industrial or residential property, the impacts of the zone on permitted uses and construction methods, and methods of mitigating the impacts on a structure that has already been constructed in the zone. Additional topics will include modernization of the FEMA FIRMs, accessing the most current map and flood study information, and assisting property owners when the determination may be inaccurate. It will also include a brief overview of the CRS

### **A) *Chimneys and Vents Instructor Julius Ballanco***

This program reviews all the design, sizing, and installation requirements that have been updated in the IFGC, IMC and IBC. With the increased use of high efficiency gas fired equipment, the design of the chimney or vent becomes very critical. The resulting failure can leak carbon monoxide into the building.
