Minutes- Motion made by Richard C, seconded by Peter S. to approve the May Minutes, all members approved.

Treasurers Report: Treasurer Zaloudek reported that from the period 5-26-11 to 6-28-11 the association paid out \$16,032.00 and took in \$5,069.05. The golf tournament took in \$26,791.00, paid out \$16,295.51, with an anticipated profit of \$10,495.00. Motion made by Joe R. and seconded by Russ H. to approve the Treasurers Report, all members approved.

Membership Report:

One new member. Mark Tebbets submitted an application for new membership, as his old membership had expired. All members approved.

Committee Appointments: No new appointments.

Committee Reports:

Scholarship- The executive Board noted that there were 9 applicants this year, four of which were new. The Board recommends award to the four new applicants. The Board agreed to forward the recommendation to the Scholarship Committee which will meet on July 6th. Bruce reported that he doesn't have a final amount available for the scholarships, but anticipates an estimated shortfall of approximately \$400- \$500.
