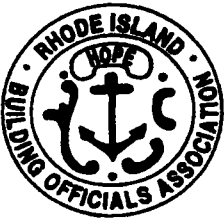

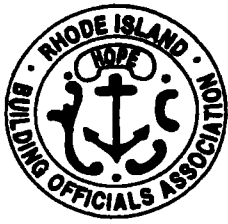
By Laws: President Wayne Pimental informed the membership that the current by-laws are being reviewed and revised and will be available for the membership to review for discussion at the April meeting.
